ENTRIES = ++PTF (SO14080) SOC4 ABEND SECSAF HANDLING MORE THAN 2 LINE MESSAGE PROBLEM DESCRIPTION: During SIGNON to CA TPX with SAF interface, the SECSAF module abends with a SOC4 when handling more than two lines in a multi-line security message. SYMPTOMS: TPX calls the security system through the SAF RACROUTE API for credentials verification. When there are more than two lines in the security multiple line message, the CA TPX SECSAF module abends with a SOC4 abnormal termination code. IMPACT: The user signing onto CA TPX is forced off, but CA TPX recovers and all other users are not impacted. CIRCUMVENTION: None.
