ENTRIES = ++PTF (LU03143) DSS SYNTAX ERROR ON RESTORE OR MISSING CANDIDATE VOLUMES PROBLEM DESCRIPTION: This PTF fixes two related issues with the DFSMSdss RESTORE OUTDYNAM parameter that FAVER uses to restore compressed files that are EXPORTed using SAVECOMP: 1) In some cases, the definition of the restored file may not include candidate volume specifications that were present when the file was exported. This occurs when DFSMSdss performs the allocation for the restored file and OUTDYNAM is specified. Specifically, this 1) The file or one of it's components is being renamed. 2) DFSMSdss decides the pre-existing target file must be scratched and reallocated (DFSMSdss issues a ADR390I messages). NOTE: The file is correctly restored and is valid. However, it may subsequently run out of space due to the lack of the expected candidate volumes. 2) DFSMSdss may issue the message: ADR124E - DELIMITER ')' IS NOT PROPERLY PRECEDED BY A CONSTANT when performing a FAVER RESTORE of a compressed file. FAVER subsequently issues one or more GV057 - CLUSTER NOT PROCESSED messages and the RESTORE fails with RC=0008 (or a U0009 abend if ESTOP is set). The DFSMSdss syntax error is due to FAVER not properly generating volume serial entries for the OUTDYNAM parameter. This fix changes FAVER to generate the correct syntax. SYMPTOMS: 1) Missing candidate volumes after restoring a compressed VSAM file when the file is being renamed or a ADR390I message is issued. 2) FAVER Restore operations may fail with RC=8 or a U0009 abend after DFSMSdss ADR124E messages. IMPACT: The FAVER Restore operation fails (for problem 2) or restores the file without candidate volumes (for problem 1). CIRCUMVENTION: None.
