What's Included in This Release

Welcome to CA Agile VisionTM (Agile Vision). The information that this document provides can help you get started with this new release.

Introduction

Agile Vision enables customers to manage projects that follow the scrum methodology in an intuitive and simple manner. Agile teams can plan product releases based on date, demand, and capacity.

Key features include:

- Ability to create multiple time-based sprints and create a product backlog easily and intuitively.
- Drag and drop capabilities for commonly executed user tasks, such as ranking the product backlog, planning sprints, and updating task status.
- Sprint burndown and velocity charts that can be viewed by team members or by all teams participating in the sprint.
- A virtual wall for managing sprint tasks.
- Agile Vision is built on Force.com. It is easy to use and always available, enabling teams to spend more time programming and less time in meetings.
- Integration of CA Clarity projects to Agile Vision projects and releases.
- Ability to manage integrated project team resources from CA Clarity.
- Synchronization of task work breakdown data from Agile Vision to CA Clarity.
- Synchronization of task worklogs from Agile Vision to CA Clarity timesheets.

Requirements

Agile Vision runs on the Force.com platform, and has the same requirements.

The following are additional requirements for integrating Agile Vision with CA Clarity:

For On Premise customers:

- CA Clarity PPM, Version 12.0.6 is installed.
- The CA Clarity Agile Enterprise add-in is installed.

For On Demand customers:

- CA Clarity PPM, Version 12.0.6 (On Demand) or CA Clarity Spring 2010 Edition is available.
- The CA Clarity Agile Enterprise add-in is available.

Browsers

Agile Vision supports the following browser versions:

- Internet Explorer version 7 and later (8 is recommended)
- Firefox version 3.5.2 and later
- Safari version 4.0.4

Upgrade from Agile Vision, Version 1.5 to Agile Vision, Version 1.7

Complete the instructions in the following sections to upgrade Agile Vision from Version 1.5 to Version 1.7. After the upgrade, the existing data is migrated to the latest fields.

The following are some examples of migrations:

- If hours are logged on a task before the upgrade, then after the upgrade, a task worklog is created.
- If comments exist in a user story before the upgrade, then after the upgrade, these comments appear in the Comments section of the user story detail rather than in the Comments field.

Install New Version of Agile Vision

1. Log out of Agile Vision and on your browser window enter the following URL:

- 2. On the Login page, enter the username and password for your system administrator org and click Login.
- 3. Enter the password provided to you for upgrading and click Submit.

The Package Installation Details page appears showing the package details and components.

4. Click Continue.

The Package Installer Agile Vision Core Step 1 page appears.

5. Click Next.

The Package Installer Agile Vision Core Step 2 page appears.

- 6. Select the security settings option to set user access by profile.
- 7. Set the following access levels for the corresponding profiles and click Next to continue:
 - Agile Vision Super-User access for the Agile Vision Super-User profile
 - Agile Vision User access for the Agile Vision User profile

The Package Installer Agile Vision Core Step 3 page appears.

- 8. Select the "Ignore Apex test failures that may cause the installed application not to function properly" check box.
- 9. Click Install.

The Processing page appears indicating that your request is in progress and that you will receive an email notification when the install is complete.

Deploy New Version of Agile Vision

1. From the Agile Vision Home page, click Setup.

The Personal Setup page appears.

- 2. Select View Installed Packages from the App Setup menu.
- 3. Verify that Agile Vision Core package, Version 1.7 is installed.
- 4. Click the Agile Vision Core package name.

The Package Details page appears.

5. Click Deploy in the Installed Package Detail section.

The Deploy Package page appears showing the package components.

6. Click Deploy again.

Complete the following additional steps to finish the upgrade:

- In the browser URL, enter "aveeUpgrade" after "apex/" as follows: https://ca-agile.na7.visual.force.com/apex/aveeupgrade
- 2. The Agile Vision Upgrade page appears.
- 3. Click Start Upgrade.

The upgrade process starts.

4. If needed, click Continue Upgrade to process further records.

When all the records are processed, the Agile Vision Upgrade page appears displaying a message that the upgrade is complete.

Configure New Version of Agile Vision

After upgrading, complete the following steps to make the new fields and objects visible on the standard SalesForce.com page layouts:

1. Login to Agile Vision and click the Setup menu.

The Personal Setup page appears.

2. Expand the Create menu and select Objects from the App Setup menu.

The Custom Objects list page appears.

- 3. Click the Agile Vision User label.
- 4. Scroll to the Page Layouts section and click Page Layout Assignment.

The Page Layout Assignment page appears.

- 5. Click Edit Assignment.
- 6. Select all profiles in the table by holding down the Ctrl key and clicking each profile name.
- 7. From the Page Layout To Use drop-down, select the Summer 10 page layout and save your changes.
- 8. Repeat the steps 1 through 7 for all the following objects:
 - Project
 - Release
 - Scrum Team Member
 - Story Dependency
 - Task
 - Team
 - User Story

Activating a Localized Language

To enable users to see fully translated languages, the system administrator needs to first activate each language for everyone. This activation needs to be completed only once. Complete the following steps to activate a language:

- 1. Log in to Agile Vision as an admin user.
- 2. Select Setup from the Navigator menu.

The personal setup page appears.

3. Click Translation Workbench from the Administration Setup menu.

The translation workbench page appears.

4. Click Translation Settings.

The translation workbench page refreshes with the supported languages.

5. Click Edit next to the language you want to activate.

The Language Translation Edit page appears.

6. In the language section, select the Active check box.

Known Issues

The following are known issues in CA Agile Vision:

Use of Decimals in User Story Points

User story points should be expressed as integers only. Agile Vision displays story points containing decimals inconsistently. If you are importing user story data using the Data Loader, be sure your user story points do not contain decimals.

Copy/Paste Edit User Story Page URL

Only Agile Vision team members for a project to create and edit user stories. A user can copy and paste the URL for the page and send it to a non-member, and the non-member can then access the page. However, a non-member cannot save any changes. They will get an insufficient privilege error message.

Setting or Clearing the Active Field

Clearing the Active field for a project, release, sprint, or team does not make it inactive.

Negative Team Velocity

This version of Agile Vision does not validate the Velocity field value when creating a scrum team. It is possible to enter a negative velocity. Team members should be careful that velocity is positive so that team metrics calculates correctly.

Online Help is only Available in English Language

The Online Help for Agile Vision is currently only available in the English language. If you set the language to something other than English in your Personal Information page, you will see the Online Help in English language.

Getting Started Guide is only Available in English Language

The *CA Agile Vision Getting Started Guide* is currently only available in the English language. If you set the language to something other than English in your Personal Information page, you will see the Getting Started Guide in English language.

Charts are not Translated

The charts on the Sprint Detail and Dashboard pages only display English text and numbers regardless of the language you select for displaying Agile Vision.

Selected Sprint is not Cleared when Project and Release Selections are Cleared

On the Dashboard page, in the Chart Options pop-up, the selected sprint is not cleared automatically when you clear the selected project and release.

Charge Codes are still Assigned to Tasks Even if they are Inactive

As a workaround, you can update the mapping so that only active charge codes are mapped to Agile Vision tasks.

If a User Story is Moved to a Different Release in Agile Vision, it is not Automatically Deleted from the CA Clarity Project

If a user story assigned to a release that integrates with CA Clarity is moved to a different release in Agile Vision, the user story is not automatically deleted from the linked CA Clarity project. You must manually delete the user story from the CA Clarity project.

 Returned Timesheets in CA Clarity are not Automatically Updated from Agile Vision

Only the open timesheets that have never been submitted in CA Clarity are automatically updated from Agile Vision. If a timesheet is in Open status after being submitted and then returned, it is not automatically updated from Agile Vision.

Restrictions on Use of the Force.com Platform

Customers may not create separate applications on the Force.com platform without prior written approval of SalesForce.com, and then only under terms and conditions mutually agreed-upon by the Customer and SalesForce.com.

The Customer may customize or extend Agile Vision using additional custom objects.

Contract Termination

Data Retention

SalesForce.com provides an API for customers to retrieve their data for any purpose, including backup or migration.
