Chapter 1: Welcome

Welcome to CA Application Delivery Analysis version 10.2. Review this document before you install or upgrade the CA Application Delivery Analysis software.

New in this Release

CA Application Delivery Analysis provides new and improved monitoring support:

■ Import VLAN Tags

This feature allows you to create a comma separated values (.csv) file to automate the task of assigning VLAN tags to domains.

■ MySQL® upgrade

This release includes an upgrade to MySQL version 5.6.

After the upgrade, the NetQoS MySQL51 service is renamed to CA MySQL service.

■ Support for NI Observer Expert version 17

The CA GigaStor Connector supports NI Observer Expert version 17. Previous versions of NI Observer Expert are no longer supported.

Issues fixed in this release:

An investigation fails to launch NI Observer Expert in context. (DE34641)

Installation

This version of CA Application Delivery Analysis is a data source for:

- CA NetQoS Performance Center 6.2
- CA Performance Center 2.3 and above

Perform a new installation of CA Application Delivery Analysis on Microsoft Windows Server 2008 R2 Standard Edition. When installing CA Application Delivery Analysis for the first time, you can choose to install on:

- A dedicated physical server
- A virtual machine

Upgrade

CA Application Delivery Analysis version 10.2 is a data source for:

- CA NetQoS Performance Center 6.2
- CA Performance Center 2.3 and above

Upgrade CA Application Delivery Analysis from version 9.2 and above to version 10.2. If you are using a release of CA Application Delivery Analysis prior to 9.2, upgrade the product to version 9.2 and then upgrade to version 10.2.

Important! The Standard Monitor and the ADA Manager must both be upgraded to version 10.2 to work properly. While the ADA Manager and a Standard Monitor are at different versions, the data collected by the monitoring device is not available for reporting.

Important! If you have CA NPC installed on the same server as CA ADA, you will receive a warning message during the upgrade of CA ADA, and you will not be allowed to continue the upgrade.

To avoid this problem, ensure that CA NPC is installed on a separate server from CA ADA before you begin the upgrade of CA ADA. For information on how to uninstall CA NPC, see Prerequisites in the *CA ADA Upgrade Guide*.

We recommend upgrading your environment in the following order:

1. Upgrade CA Multi-Port Monitor appliances before you upgrade CA Application Delivery Analysis. CA Multi-Port Monitor version 10.2 is compatible with CA ADA version 10.0 and above.

Important! CA ADA versions 10.0 and above are **not** compatible with CA Multi-Port Monitor version 9.2 and below. If you upgrade the CA ADA Manager to version 10.0 or above, you will be required to upgrade a version 9.2 or below Multi-Port Monitor to version 10.0 or above to resume data collection. Use the table below to see CA ADA and CA MTP version compatibility.

- 2. Upgrade the Standard Monitors, if installed.
- 3. Upgrade the ADA Manager.
- 4. As part of the upgrade process, you should also plan to upgrade the following products, if installed, to the supported versions listed below:
 - CA Multi-Port Monitor version 10.2
 - NI GigaStor appliance with:
 - NI Observer Expert version 17
 - CA GigaStor Connector version 10.2

This release of CA ADA includes an upgrade of the MySQL database from version 5.1 to 5.6. Data is backed up, then restored at the completion of the upgrade. Ensure that you have enough available disk space to backup the MySQL database.

You can use the table below to estimate the amount of time the upgrade will take to complete. Note that these figures are only an estimate. The amount of time required for the upgrade to complete will vary, depending on the number and speed of CPU(s), disk i/o rate, and the amount of RAM available on your system. Use these figures as general guidelines only.

Chapter 2: Known Issues with this Release

This section describes known issues with this release and suggests workarounds.

CA NPC Cannot be Co-located with CA ADA

This release of CA ADA includes an upgrade of the MySQL database from version 5.1 to 5.6.

CA NetQoS Performance Center (CA NPC) requires MySQL version 5.1.

If you have CA NPC installed on the same server as CA ADA, you will receive a warning message during the upgrade of CA ADA, and you will not be allowed to continue.

To avoid this problem, ensure that CA NPC is installed on a separate server from CA ADA before you begin the upgrade or installation of CA ADA. For help with uninstalling CA NPC, see the *Upgrade Guide*.

CA GigaStor Connector requires NI Observer Expert version 17 in Expert Mode

This release of CA Application Delivery Analysis requires the upgrade of NI Observer Expert to version 17. During the upgrade of NI Observer Expert on the NI GigaStor appliance, ensure that Expert Mode is selected. If NI Observer Expert is not installed in Expert Mode, the CA GigaStor Connector will be unable to process data from the NI GigaStor appliance.

Permission Set Limitation

When bound to CA Performance Center, the CA Application Delivery Analysis management console enforces permission sets, however, the Multi-Port Monitor does not. For example, if a user has permission to a particular group of servers, and the Multi-Port Monitor can monitor at least one of the servers in the group:

- In CA Performance Center, access is limited to the servers in the permission set.
- In CA Application Delivery Analysis data source, access is limited to the servers in the permission set.
- In Multi-Port Monitor, the Analysis tab displays performance data for all servers in the domain.

If necessary, restrict CA Application Delivery Analysis data source access to avoid giving a user access to data in the Multi-Port Monitor that is outside their permission set.

Note: Restricting the Drill into Data Sources role right does not prevent a user from directly accessing the CA Application Delivery Analysis management console and Multi-Port Monitor.

Documentation Upgrade

After upgrading CA ADA to version 10.2, links in the ADA Console Online Help incorrectly point to the documentation for the previous version. To fix this problem, take the following steps:

- Open the file C:\CA\SuperAgent\dotnet\Console\web.config with a text editor.
- 2. Locate the two lines:

- 3. Change SA UserGuide.pdf to ada User.pdf
- 4. Change SA_AdminGuide.pdf to ada_Admin.pdf
- 5. Save the file.

Internet Explorer with Quirks Mode

When accessing the management console through Internet Explorer 8, the page formatting appears incorrect at the top of the page.

To avoid this issue, press F12 in Internet Explorer and then set the Browser Mode to IE8 and the Document Mode to Quirks.



Therefore, if a Contributor includes the Program in a commercial product offering, such Contributor ("Commercial Contributor") hereby agrees to defend and indemnify every other Contributor ("Indemnified Contributor") against any losses, damages and costs (collectively "Losses") arising from claims, lawsuits and other legal actions brought by a third party against the Indemnified Contributor to the extent caused by the acts or omissions of such Commercial Contributor in connection with its distribution of the Program in a commercial product offering. The obligations in this section do not apply to any claims or Losses relating to any actual or alleged intellectual property infringement. In order to qualify, an Indemnified Contributor must: a) promptly notify the Commercial Contributor in writing of such claim, and b) allow the Commercial Contributor to control, and cooperate with the Commercial Contributor in, the defense and any related settlement negotiations. The Indemnified Contributor may participate in any such claim at its own expense.

For example, a Contributor might include the Program in a commercial product offering, Product X. That Contributor is then a Commercial Contributor. If that Commercial Contributor then makes performance claims, or offers warranties related to Product X, those performance claims and warranties are such Commercial Contributor's responsibility alone. Under this section, the Commercial Contributor would have to defend claims against the other Contributors related to those performance claims and warranties, and if a court requires any other Contributor to pay any damages as a result, the Commercial Contributor must pay those damages.

5. NO WARRANTY

EXCEPT AS EXPRESSLY SET FORTH IN THIS AGREEMENT, THE PROGRAM IS PROVIDED ON AN "AS IS" BASIS, WITHOUT WARRANTIES OR CONDITIONS OF ANY KIND, EITHER EXPRESS OR IMPLIED INCLUDING, WITHOUT LIMITATION, ANY WARRANTIES OR CONDITIONS OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Each Recipient is solely responsible for determining the appropriateness of using and distributing the Program and assumes all risks associated with its exercise of rights under this Agreement, including but not limited to the risks and costs of program errors, compliance with applicable laws, damage to or loss of data, programs or equipment, and unavailability or interruption of operations.

6. DISCLAIMER OF LIABILITY

EXCEPT AS EXPRESSLY SET FORTH IN THIS AGREEMENT, NEITHER RECIPIENT NOR ANY CONTRIBUTORS SHALL HAVE ANY LIABILITY FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, OR CONSEQUENTIAL DAMAGES (INCLUDING WITHOUT LIMITATION LOST PROFITS), HOWEVER CAUSED AND ON ANY THEORY OF LIABILITY, WHETHER IN CONTRACT, STRICT LIABILITY, OR TORT (INCLUDING NEGLIGENCE OR OTHERWISE) ARISING IN ANY WAY OUT OF THE USE OR DISTRIBUTION OF THE PROGRAM OR THE EXERCISE OF ANY RIGHTS GRANTED HEREUNDER, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

7. GENERAL

If any provision of this Agreement is invalid or unenforceable under applicable law, it shall not affect the validity or enforceability of the remainder of the terms of this Agreement, and without further action by the parties hereto, such provision shall be reformed to the minimum extent necessary to make such provision valid and enforceable.

If Recipient institutes patent litigation against a Contributor with respect to a patent applicable to software (including a cross-claim or counterclaim in a lawsuit), then any patent licenses granted by that Contributor to such Recipient under this Agreement shall terminate as of the date such litigation is filed. In addition, if Recipient institutes patent litigation against any entity (including a cross-claim or counterclaim in a lawsuit) alleging that the Program itself (excluding combinations of the Program with other software or hardware) infringes such Recipient's patent(s), then such Recipient's rights granted under Section 2(b) shall terminate as of the date such litigation is filed.

All Recipient's rights under this Agreement shall terminate if it fails to comply with any of the material terms or conditions of this Agreement and does not cure such failure in a reasonable period of time after becoming aware of such noncompliance. If all Recipient's rights under this Agreement terminate, Recipient agrees to cease use and distribution of the Program as soon as reasonably practicable. However, Recipient's obligations under this Agreement and any licenses granted by Recipient relating to the Program shall continue and survive.

Everyone is permitted to copy and distribute copies of this Agreement, but in order to avoid inconsistency the Agreement is copyrighted and may only be modified in the following manner. The Agreement Steward reserves the right to publish new versions (including revisions) of this Agreement from time to time. No one other than the Agreement Steward has the right to modify this Agreement. IBM is the initial Agreement Steward. IBM may assign the responsibility to serve as the Agreement Steward to a suitable separate entity. Each new version of the Agreement will be given a distinguishing version number. The Program (including Contributions) may always be distributed subject to the version of the Agreement under which it was received. In addition, after a new version of the Agreement is published, Contributor may elect to distribute the Program (including its Contributions) under the new version. Except as expressly stated in Sections 2(a) and 2(b) above, Recipient receives no rights or licenses to the intellectual property of any Contributor under this Agreement, whether expressly, by implication, estoppel or otherwise. All rights in the Program not expressly granted under this Agreement are reserved.

This Agreement is governed by the laws of the State of New York and the intellectual property laws of the United States of America. No party to this Agreement will bring a legal action under this Agreement more than one year after the cause of action arose. Each party waives its rights to a jury trial in any resulting litigation.
