

VMware Tanzu Spring Essentials Specific Program Documentation ("SPD")

The Broadcom software program(s) ("Broadcom Software" or "Software") listed below is provided under the following terms and conditions in addition to any terms and conditions referenced on the Broadcom quote, order form, statement of work, or other mutually agreed ordering document (each a "Transaction Document") under the applicable end user agreement or governing contract (collectively, the "Agreement") entered into by Customer and the Broadcom entity ("Broadcom") through which Customer obtained a license for the Broadcom Software. These terms shall be effective from the effective date of such Transaction Document. Capitalized terms have the meanings ascribed to them herein, or, otherwise, in the Agreement (including the VMware Licensing Glossary).

VMware Tanzu Spring Essentials provides the following capabilities and entitlements:

 - Access to Spring Enterprise artifact repository
 - Application Advisor to support compliance via app upgrades and recommendations
 - Enterprise Spring Boot extensions
 - o Enterprise Spring Cloud components
 - Access to binary downloads of Tanzu Distribution of OpenJDK™, Apache Tomcat and Tanzu tc Server
 - Support for
 - 50+ open source Spring projects
 - OpenJDK™
 - Apache Tomcat
- Tanzu Build Service
 - o Create an OCI image from application source code using Cloud Native Buildpacks.

1. DEFINITIONS

All terms defined in the VMware Licensing Glossary located at http://www.broadcom.com/company/legal/licensing apply to this SPD unless specified herein.

"Coding Agent" is an autonomous software tool, often leveraging artificial intelligence, that can handle various coding tasks. These include interpreting requirements, writing code, and running tests. Coding agents can operate independently or in collaboration to improve the software development process, making decisions and adapting to changes as needed.

"Compiled Artifact JAR" is a Java Archive (JAR) file that contains the compiled binaries to be downloaded and incorporated into applications.

"Developer" means an individual who creates or modifies source code. The Developer may be: (a) employed by Customer; or (b) under contract with Customer; or (c) a source code contribution account representing a Coding Agent or Service Account.

"Service Account" is a source code repository account that is not associated with a single person. These accounts are used in situations such as continuous integration and test environments.

"Source JAR" is a Java Archive (JAR) file that contains the associated source code associated with the corresponding Compiled Artifact JAR file.

"Tanzu Spring Essentials Unit" is a consumption unit that is convertible to units of Tanzu Spring Essentials components, specifically Cores.

2. USE RIGHTS AND LIMITATIONS.

The Software is licensed as Subscription Software. Customer may use the Software and Support solely during the Subscription term. Customer must pay for all the Software Customer uses.

The Software is licensed based on Tanzu Spring Essentials Units. One Tanzu Spring Essentials Unit equals one Core, for which the total represents the number of Cores used to run Spring applications or images generated by Tanzu Build Service.

Alternatively, for the number of Cores used to run Spring applications, Customer may choose to use the Developer metric with a ratio of one Developer to five Cores.

Source JARs may only be used for debugging and troubleshooting purposes. Customer may not use any Source JAR to generate a new Compiled Artifact JAR. Only the corresponding Compiled Artifact JAR provided by Broadcom as Software will be eligible for Support during the Subscription term. Source JARs and Complied Artifact JARs are both provided by Broadcom in the same folder inside a Maven repository.

At the end of the Subscription term, Customer may have the option to renew the Subscription licenses. If Customer does not renew, the Subscription licenses shall expire at the end of the Subscription term. Upon expiration or termination of Customer's licenses to the Software, Customer must cease use of the Software, Documentation and Support and certify cessation of use to Broadcom.

Broadcom may, at its discretion, retire Software and/or Support from time to time.
