#### Localization

eTrust AC is localized (translated) into three languages - Japanese, Korean, and Simplified Chinese - for both UNIX and Windows platforms. The localized versions are available on the eTrust AC CD with the English version. You can select the language of your installation during setup.

Localized versions of the eTrust AC Administrator Guide, eTrust AC Getting Started, and eTrust AC Release Summary are also available.

**Note:** For more information about available localized and internationalized product versions, see your *readme* file.

# **Advanced Policy Management and Reporting**

eTrust AC now extends the functionality offered by the existing automatic rule-based policy management. This existing method supports policy propagation by establishing a Policy Model hierarchy. With advanced policy management and reporting, multiple-rule policies (script files) you create can be deployed in a configured hierarchy. Using this policy-based method, you can deploy and remove deployed policies (undeploy), and create reports on deployment status, deployment deviation, and deployment hierarchy.

**Note:** For more information on advanced policy management and reporting, see your *Administrator Guide*.

#### **Components of Advanced Policy Management**

To make this functionality available, eTrust AC offers three essential new components:

#### **Deployment Map Server (DMS)**

The DMS sits at the core of advanced policy management and reporting. The purpose of DMS is to keep an up-to-date map of the eTrust AC deployment hierarchy and the status of policies deployed on each computer. Having this data in a central location (rather than connecting to each database in a hierarchical manner) reduces the time required for generating reports.

#### Deployment Map Agent (DMA)

The DMA is an agent that is responsible for Policy Model communication with the DMS. The DMA is responsible for notifying the DMS of policy deployment status and hierarchy changes.

#### **Policy Deviation Calculator**

The policy deviation calculator is installed and configured on each eTrust AC end-point. It reports back to the DMS on policy deviation status, and lets you see the difference between the policy rules that are meant to be deployed on the end-point, and the actual policy rules that are applied on the end-point. This information lets you deal with problems associated with the deployment of your policies.

In addition, eTrust AC provides three new classes (HNODE, POLICY, and RULESET) to support this functionality, a policy deployment utility (policydeploy), and a policy and hierarchy reporting utility (policyreport).

#### **Host and Policy Reports**

Advanced policy management reporting functionality offers two types of reports:

#### Host reports.

Host reports present computer-centric information. Use this mode when you want to view your environment by host. In this mode you can see how your computers are configured, what is the status of each computer in your hierarchy, and, if multiple-rule policies have been deployed, which computers have which policies and what their status is, and how the actual rules deployed deviate from the rules that should be deployed on each computer.

You only need to install and configure your DMS and any DMAs to benefit from this report.

#### Policy reports.

Policy reports present policy-centric information. Use this mode when you want to view the deployment status and policy deviation status of one or more policies throughout your environment. In addition, you can also request to include policy deviation data. This data lets you see the difference between the policy rules that are meant to be deployed on the end-point, and the actual policy rules that are applied on the end-point.

## **AES Encryption**

Communication between different eTrust AC components and between services on different servers is encrypted. eTrust AC now supports Advanced Encryption Standard (AES) encryption for these communications. It provides a pluggable module (DLL on Windows and a shared library on UNIX) for each of the AES specification's three key sizes: 128, 192, and 256 bits.

#### **More Supported Platforms**

The eTrust AC platform coverage has been extended to support more of the latest versions of major enterprise operating systems. This includes Windows, Linux, Solaris, HP, and AIX.

**Note:** For a full list of the platforms supported for UNIX and Windows, see the *Readme for UNIX* and *Readme for Windows* respectively.

#### **Solaris 10 Zone Support**

Solaris 10 provides virtualized OS services which behave like different Solaris instances. These let you run many virtual copies of Solaris 10 with a single computer hardware, using one Solaris 10 kernel. All Solaris 10 systems contain a master zone, called the *global zone*. Non-global zones run along side it, yet you can configure, monitor, and control them from the global zone.

eTrust AC now supports these virtual zones by providing the following functionality:

- Install and protect selected zones using separate eTrust AC instances.
- Define different rules and policies for each zone, letting you define different access restrictions for each zone.

**Note:** For more information about Solaris 10 Zone support, see the *Implementation Guide*.

#### **Solaris Native Installation**

eTrust AC now offers the Sun Solaris native package format for installation on Solaris operating systems. This is a command line driven package management system capable of installing, uninstalling, verifying, quering, and updating software packages.

**Note:** For more information about Solaris native installations, see the *Implementation Guide*.

# **Trace Messages Filtering for UNIX**

eTrust AC now lets you filter audit trace records according to a specified mask. The feature lets you specify filter masks for filtering out eTrust AC trace messages and trace messages that are sent to the audit file (for use with the "trace" audit mode). A trace filter file specifies the trace messages that are to be filtered out (that is, those messages that are not to appear in the trace or audit file).

**Note:** For more information about the trace filter file, see the *Implementation Guide*.

# LDAP Support for Look-aside Database for UNIX

The sebuildla utility creates a look-aside database for use by the eTrust AC daemon, seosd. The seosd daemon uses the internal database to translate UNIX UIDs to user names, GIDs to group names, host IP addresses to host names, and service ports to port names. The database contains only the number-to-name translation.

eTrust AC now lets you extract user information (using sebuildla) from an LDAP Directory Information Tree (DIT).

**Note:** For more information about the sebuildla utility, see the *Utilities Guide* for *UNIX*.

## System Call Monitor for UNIX

You cannot unload eTrust AC if an application, which is loaded on top of eTrust AC, has an open system call (syscall) that is hooked by eTrust AC. eTrust AC now lets you view processes that are still executing eTrust AC code so that you can shut down these processes and unload eTrust AC.

**Note:** For more information, see the secons utility in the *Utilities Guide for UNIX*.

#### **SEOS Loader Exits for UNIX**

eTrust AC now provide SEOS Loader (SEOS\_load) exits that let you run commands during kernel module initialization and removal. This lets you automatically maintain products (external resources, operating system, or third-party) that may interfere with eTrust AC.

eTrust AC provides several out of the box exit files that are designed to deal with some of the most widespread and critical issues. You should not modify these files. Instead, you can use the API to create your own exits for any specific needs.

#### **Audit Filtering for Windows**

eTrust AC now lets you filter audit records on a host by defining audit records that should not be generated. Filtering audit files helps to limit the size of the eTrust AC audit file by keeping only the records needed. You can set filtering rules for class name, object name, user name, program name, access rights, and authorization result.

**Note:** This functionality already existed in eTrust AC for UNIX in previous versions. For more information about audit filtering for Windows, see the *Administrator Guide for Windows*.

# sereport for Windows

eTrust AC now makes the sereport utility available for the Windows platform as well. sereport provides HTML reports, accessible from a web browser, of database and Policy Model information.

**Note:** This utility already existed in eTrust AC for UNIX in previous versions. For more information about sereport utility for Windows, see the *Reference Guide for Windows*.

#### **Product Explorer for Windows**

eTrust AC now offers the Product Explorer as an easy and convenient way to explore the eTrust AC CD, and to install the various eTrust AC components, accompanying documentation, and supporting products. If you have Autorun enabled, the Product Explorer automatically appears when you insert the eTrust AC CD.

The Product Explorer also lets you know which components are already installed, what are the system requirements for installing each component, and lets you view the documentation directly from the CD.

#### **iRecorder Support of PMD Audit Records**

eTrust AC iRecorder now supports sending Policy Model (PMD) audit records. The eTrust AC iRecorder API was also enhanced to collect audit records from PMD audit files. It allows preparing a list of PMDs and reading PMD audit records one by one.

**Note:** For more information about the iRecorder API, see the *SDK Guide*. For more information about eTrust AC iRecorder, see the *eTrust Audit iRecorder Reference Guide for eTrust Access Control* available from SupportConnect.

## **System Files Bypass for UNIX**

eTrust AC now lets you control whether eTrust AC authorization bypasses system files. This lets you prevent users from having access to read system files (for example, /etc/passwd and /etc/group).

By default, eTrust AC authorization bypasses read access to system files. To change this, use the bypass\_system\_files token of the seos.ini initialization file.

**Note:** For more information about the bypass\_system\_files token, see the *Reference Guide for UNIX*.

#### **RPM Native Installation for UNIX**

The RPM format of eTrust AC installation files has been enhanced to provide repackaging. By repackaging the eTrust AC client-server package, you can create a customized package for a silent installation of eTrust AC using native RPM.

seosd in Windows and selogrd in UNIX now send detailed information to Unicenter Event Management. This information now includes the product name, user name, class name, terminal name, time, and severity mode.

## 1.5

#### 2. LICENSE GRANTS.

- 2.1 Development License Grant. - 2.2 Deployment and Distribution License Grant. Subject to the terms and conditions of this License Agreement, Rogue Wave grants to Licensee a nonexclusive, nontransferable, perpetual, royalty-free, limited right and license to: (a) install and use the RW Libraries in connection with the execution of Applications created in compliance with Section 2.1, on CPUs owned or leased by Licensee or contractors under Licensee's control, which are located at facilities owned or leased by Licensee or contractors under Licensee's control; (b) distribute and grant to Licensee's customers pursuant to a license agreement at least as protective of the rights of Rogue Wave as this License Agreement the right to install and use the RW Libraries in connection with the execution of Applications created in compliance with Section 2.1, on CPUs owned or leased by such customers or contractors under such customers' control, which are located at facilities owned or leased by such customers or contractors under such customers' control; and (c) copy or have copied the RW Libraries embedded in or used in the execution of Applications as necessary for the purpose of exercising the rights granted under this Section 2.2 or for back-up or disaster recovery purposes, provided, that Rogue Wave's copyright notice and other proprietary rights notices are reproduced on each copy.

#### 3. LICENSE RESTRICTIONS AND LICENSEE RESPONSIBILITIES.

**3.1 Development Restrictions.** The development rights granted to Licensee in Section 2.1 may only be exercised by individual developers employed by or under contract to Licensee that Licensee has designated as "Licensed Developers" and for whom Licensee has paid the applicable per product or per module development license fees. If one Licensed Developer ceases to be employed by or under contract to Licensee or permanently ceases work on projects involving the Licensed Software, then Licensee may designate an alternate developer to replace such Licensed Developer at no additional cost. However, the development license is not a concurrent license that may be used by numerous developers in shifts. - **3.3 Proprietary Protection.** Rogue Wave shall have sole and exclusive ownership of all right, title, and interest in and to the Licensed Software and all modifications and enhancements thereof (including ownership of all trade secrets and copyrights pertaining thereto), subject only to the rights and privileges expressly granted to Licensee herein by Rogue Wave. This License Agreement does not provide Licensee with title or ownership of the Licensed Software, but only a right of limited use. Licensee must keep the Licensed Software free and clear of all claims, liens, and encumbrances.

- 3.4 Compliance Verification. Licensee must have a commercially-reasonable process in place to track the number of developers using the Licensed Software in order to ensure that the appropriate license fees have been paid. Licensee will, upon Rogue Wave's request, certify in writing the number developers using the Licensed Software, on a per product or per module basis, as of the date of the request. In the event Licensee fails to provide such certification within thirty (30) days of Rogue Wave's request, or, if Rogue Wave reasonably believes that a certification provided by Licensee is inaccurate or that Licensee is otherwise not in compliance with the terms of this License Agreement, Licensee will permit Rogue Wave, or a mutually-approved independent representative, to enter Licensee's premises, during regular business hours, to verify Licensee's compliance with the terms of this License Agreement.
- 3.5 Confidentiality of Source Code. Licensee agrees to maintain in confidence the source code version of the Licensed Software by using at least the same physical and other security measures as Licensee uses for its own confidential technical information and documentation, but in no case less than reasonable measures. Licensee further agrees not to disclose the source code version of the Licensed Software, or any aspect thereof (including, without limitation, header files), to anyone other than employees or contractors who have a need to know or obtain access to such information in order to support Licensee's authorized use of the Licensed Software and are bound to protect such information against any other use or disclosure. Rogue Wave assumes no responsibility under this License Agreement, either directly or indirectly, for damages to Licensee or third parties resulting from the direct or indirect use of the Applications created by or on behalf of Licensee and Licensee shall defend and hold harmless Rogue Wave from any such damages. Licensee hereby agrees to indemnify and hold harmless Rogue Wave from and against any and all claims, actions, or demands arising with respect to Applications developed and/or distributed by Licensee, with the sole exception of those matters for which Rogue Wave bears responsibility under Section 6 of this License Agreement. The foregoing indemnity shall be contingent upon Rogue Wave: (1) giving written notice to the Licensee of any claim, demand, or action for which indemnity is sought; (2) fully cooperating in the defense or settlement of any such claim, demand, or action; and (3) obtaining the prior written agreement of the Licensee to any settlement or proposal of settlement.

- **5.3 DISCLAIMER.** EXCEPT FOR THE LIMITED WARRANTY SET FORTH IN SECTION 5.1 ABOVE, THE LICENSED SOFTWARE IS PROVIDED "AS IS," WITHOUT REPRESENTATIONS OR WARRANTIES OF ANY KIND. ROGUE WAVE SPECIFICALLY DISCLAIMS ALL OTHER PROMISES, REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT, AND ANY IMPLIED WARRANTY ARISING FROM COURSE OF PERFORMANCE OR COURSE OF DEALING.

5.4 LIMITATION OF LIABILITY. THE CUMULATIVE LIABILITY OF ROGUE WAVE TO LICENSEE FOR ALL CLAIMS RELATING TO THE LICENSED SOFTWARE AND THIS LICENSE AGREEMENT, INCLUDING ANY CAUSE OF ACTION SOUNDING IN CONTRACT, TORT, OR STRICT LIABILITY, SHALL NOT EXCEED THE TOTAL AMOUNT OF ALL LICENSE FEES PAID TO ROGUE WAVE HEREUNDER. THIS LIMITATION OF LIABILITY IS INTENDED TO APPLY WITHOUT REGARD TO WHETHER OTHER PROVISIONS OF THIS LICENSE AGREEMENT HAVE BEEN BREACHED OR HAVE PROVEN INEFFECTIVE. THIS LIMITATION OF LIABILITY SHALL NOT APPLY TO THE INDEMNIFICATION PROVIDED IN SECTION 6 HEREOF. If the breach is cured within the thirty (30) day grace period, then this License Agreement will remain in effect; otherwise, this License Agreement will automatically terminate upon the conclusion of the thirty (30) day grace period.

The following sentence is added to the end of item 2 of the first paragraph:

IBM's liability under this item is limited to the violation of essential contractual terms in cases of ordinary negligence.

INDIA:

Limitation of Liability:

The following replaces items 1 and 2 in the first paragraph:

1) liability for bodily injury (including death) or damage to real property and tangible personal property will be limited to that caused by IBM's negligence; and 2) as to any other actual damage arising in any situation involving nonperformance by IBM pursuant to, or in any way related to the subject of this agreement, IBM's liability will be limited to the charge paid by Licensee for the individual Program that is the subject of the claim, which Licensee acknowledges is \$0.

General:

The following replaces the second paragraph of this Section:

With respect to any claim by or against IBM relating to the Program, if no suit or other legal action is brought, within two years after the cause of action arose, in respect of any claim that either party may have against the other, the rights of the concerned party in respect of such claim will be forfeited and the other party will stand released from its obligations in respect of such claim.

IRELAND:

Limited Warranty:

The following paragraph is added to this Section:

Except as expressly provided in these terms and conditions, all statutory conditions, including all warranties implied, but without prejudice to the generality of the foregoing, all warranties implied by the Sale of Goods Act 1893 or the Sale of Goods and Supply of Services Act 1980 are hereby excluded.

Limitation of Liability:

The following replaces items 1 and 2 in the first paragraph of this Section:

1) death or personal injury or physical damage to Licensee's real property solely caused by IBM's negligence; and 2) the amount of any other actual direct damages, up to the greater of EUR 100,000 in respect of Programs or 125 percent of the charges for the Program that is the subject of the claim or which otherwise gives rise to the claim, which Licensee acknowledges is \$0.

The following paragraph is added at the end of this Section:

IBM's entire liability and Licensee's sole remedy, whether in contract or in tort, in respect of any default will be limited to damages.

ITALY:

Limitation of Liability:

The following replaces the second sentence in the first paragraph:

In each such instance unless otherwise provided by mandatory law, IBM is liable for no more than damages for bodily injury (including death) and damage to real property and tangible personal property and 2) as to any other actual damage arising in all situations involving non-performance by IBM pursuant to, or in any way related to the subject matter of this Agreement, IBM's liability, will be limited to the total amount Licensee paid for the Program that is the subject of the claim, which Licensee acknowledges is \$0.

NEW ZEALAND:

Limited Warranty:

The following paragraph is added to this Section:

The warranties specified in this Section are in addition to any rights Licensee may have under the Consumer Guarantees Act 1993 or other legislation which cannot be excluded or limited. The Consumer Guarantees Act 1993 will not apply in respect of any goods or services which IBM provides, if Licensee requires the goods or services for the purposes of a business as defined in that Act.

Limitation of Liability:

The following paragraph is added to this Section:

Where Programs are not acquired for the purposes of a business as defined in the Consumer Guarantees Act 1993, the limitations in this Section are subject to the limitations in that Act.

PEOPLE'S REPUBLIC OF CHINA:

Charges:

The following paragraph is added as a new Section:

All banking charges incurred in the People's Republic of China will be borne by Licensee and those incurred outside the People's Republic of China will be borne by IBM.

UNITED KINGDOM:

Limitation of Liability:

The following replaces items 1 and 2 in the first paragraph of this Section:

1) death or personal injury or physical damage to Licensee's real property solely caused by IBM's negligence; 2) the amount of any other actual direct damages, up to the greater of Pounds Sterling 75,000 in respect of Programs or 125 percent of the charges for the Program that is the subject of the claim or which otherwise gives rise to the claim, which Licensee acknowledges is \$0.

The following item is added:

3) breach of IBM's obligations implied by Section 12 of the Sale of Goods Act 1979 or Section 2 of the Supply of Goods and Services Act 1982.

The following paragraph is added at the end of this Section:

IBM's entire liability and Licensee's sole remedy, whether in contract or in tort, in respect of any default will be limited to damages.
